Punishment prescribed for each offense (30.200(c)(4))	<p>For CF582-01: Sentenced to three (3) years imprisonment, with credit for time served; pay fine of \$5000; pay full restitution to victim; place on parole for three (3) years, the sentence shall include a special parole term of not less than three (3) years in addition to such term of not less than three (3) years in addition to such term of imprisonment. The sentence imposed under this Section shall run consecutive to any sentence already imposed on the offender for any other offense at the time he is sentenced under this Section.</p> <ul style="list-style-type: none"> - Shall stay away, directly and indirectly, from the victims, [victim's name omitted], and their families. The defendant shall not contact the same by telephone, in writing, and/or through a third party, including a family member or friend; - Shall not come within five hundred (500) feet of the victims, [victim's name omitted]; - Shall stay away from the residence, dwelling, school, day care center, or place of employment of the victims, [victim's name omitted], or any other specified place, and shall not come within five hundred (500) feet of the above specified places; - Shall not attend any function and/or establishment, including family and/or social functions, if he knows or becomes aware that the victims, [victim's name omitted], will be present. Upon becoming aware of the victim's presence, or planned leave the function and/or establishment; - Shall not threaten, physically strike, or injure the victims, [victim's name omitted]; - Shall stay away from the business establishment of K-MART; - Shall report to the Parole Officer once a week in person, or as recommended by the Parole Office; - Defendant stipulates to forfeit any contraband and cash seized to the Guam Police Department for Drug Training, and all other non-contraband personal items will be returned to the Defendant; - Shall not associate with any felons known to him as felons, including his co-actors; - Shall seek and attempt to maintain full-time legitimate employment, effective immediately, and that the Parole Office shall monitor Defendant's progress monthly; - Shall not possess or consume any alcoholic beverages, and shall not enter any establishments whose primary business is the sale of alcoholic beverages; - Shall not possess or consume any illegal controlled substances; - Shall stay away from all firearms, and is not to possess, carry, transfer, or use any firearms; - Shall forfeit his firearm identification card to the court and shall not reapply for another one. 18 U.S.C. § 922 makes it unlawful for any person subject to an order for protection or convicted of

Failure to allow such a search will be considered a violation of parole;- Shall turn in his passport and/or other travel documents to the Clerk of Court;- Shall not go near any port of entry/exit;- Shall comply with any other condition imposed by the court or the Parole Office;- Shall comply with any court orders entered against the Defendant, including orders of family court and any other local or federal court of competent jurisdiction;- Shall obey all local and federal laws; and,- Shall not leave Guam without the approval of the court or Parole Office, with prior notice being given to the Office of the Attorney General, Prosecution Division. <p>CM93-07: Sentenced to one (1) year, all but ninety (90) days suspended, with credit for time served; pay fine of \$1000, plus Court cost; Pay full restitution; place on two (2) years supervised probation during which time the following terms and conditions of probation shall be imposed:</p> <ul style="list-style-type: none">- Shall stay away, directly and indirectly, from the victim, [victim's name omitted]. Shall not contact the same by telephone, in writing, and/or through a third party, including a family member or friend;- Shall not come within five hundred (500) feet of the victim, [victim's name omitted];- Shall stay away from the residence, dwelling, school, day care center, or place of employment of the victim, [victim's name omitted], or any other specified place, and shall not come within five hundred (500) feet of the above specified places;- Shall not harass, assault, threaten, physically strike, or injure the victim, [victim's name omitted];- Shall perform one hundred fifty (150) hours of community service under the direction of the Alternative Sentencing Office;- Shall report to the Client Services and Family Counseling Division of the court for intake and assessment. 	<p>the fee for the program;</p> <ul style="list-style-type: none"> - Shall report to the Adult Probation Office once a month in person, or as ordered by the Adult Probation Office; - Shall stay away from all firearms, and is not to possess, carry, transfer, or use any firearms; - Shall forfeit his firearm identification card to the court and shall not reapply for another one; - Shall not apply for, possess, or own a firearm identification card; - All firearms must be removed from the Defendant's residence and surrendered to the Adult Probation Office until disposition of this case. Defendant is to surrender his firearms and firearms identification card to the Adult Probation Office. 18 U.S.C. § 922 makes it unlawful for any person subject to an order for protection or convicted of a misdemeanor crime of domestic violence to ship, transport, possess, or receive firearms or ammunition; - Shall submit to random drug or alcohol testing at the request of the Adult Protection Office. Failure to submit to testing shall be considered a violation; - Shall permit probation officers to search his person, residence and vehicles for any firearms, alcoholic beverages, or controlled substances, at any time such a search is requested. Failure to allow such a search will be considered a violation of probation; - Shall surrender his passport and/or other travel documents, if any, to the Adult Probation Office; - Shall not leave Guam without the approval of the Court or Adult Probation Office, with prior notice being given to the Office of the Attorney General, Prosecution Division; - Shall abide by any other reasonable conditions imposed by the Court or the Adult Probation Office. - Shall comply with any court orders entered against the Defendant, including orders of family court or any other local or federal court of competent jurisdiction; and - Shall obey all laws of Guam. <p>CM1044-13: Sentenced to one (1) one year imprisonment, all but three (3) months suspended, with credit for time served; pay fine of \$200; Pay full restitution; place on two (2) years of supervised probation, provided that the Defendant complete the following conditions:</p> <ul style="list-style-type: none"> - Shall stay away, directly and indirectly, from the victim [victim's name omitted], and or any witnesses. Shall not contact the same by telephone, in writing, and/or through a third party, including a family member or friend; - Shall stay away from the residence, swelling, school, day care center, or place of employment of the victim, [victim's name omitted] or any other specified place, and shall not come within five hundred (500) feet or the above specified places; - Shall not attend any function and/or establishment, including family and/or social functions, if he knows or becomes aware

Failure to allow such a search will be considered a violation of probation; - Shall comply with any other condition imposed by the court or the Adult Probation Office; - Shall comply with any court orders or any other local or federal court of competent jurisdiction; - Shall obey all local and federal laws; and, - Shall not leave Guam without the approval of the court or Adult Probation Office, with prior notice being given to the Office of the Attorney General, General Crimes Division. <p>CF0371-16: Sentenced to one (1) year incarceration, with all but three (3) months suspended, with credit for time served, and a release date of September 9, 2016; placed on supervised probation for a period of two (2) years, during which time the following terms and condition of probation shall be imposed:</p> <ul style="list-style-type: none"> - Shall stay away, directly and indirectly, from [victim's name omitted]. Shall not contact the same by telephone, in writing, or through a third party, including a family member or friend;
