

<b>Punishment prescribed for each offense</b> (30.200(c)(4))	<b>For CF270-16:</b> Sentenced to three (3) years imprisonment, all but three (3) months suspended, with credit for time served.

	<p><b><u>For CM536-09:</u></b></p> <ul style="list-style-type: none"> <li>a. Sentenced to one (1) year imprisonment at the Department of Corrections, all suspended, with credit for time served.</li> <li>b. Pay a two hundred fifty dollar (\$250.00) fine, plus court costs. Fine convertible to community service at the current minimum wage rate per hour.</li> <li>c. Pay full restitution, if any, in an amount to be determined by the court at the restitution hearing. Defendant shall pay said restitution in monthly installment to be arranged by the Adult Probation Office and shall pay it in full prior to termination of probation period. However, in the event that restitution is not paid by the expiration of probation, the obligation for restitution shall survive.</li> </ul>
<p><b>Indication as to whether the person was discharged, placed on probation, or community supervision, or release on parole or to mandatory supervision following the conviction for each offense (30.200(c)(5))</b></p>	<p><b><u>For CF27-16:</u></b></p> <p>Placed on probation for a period of two (2) years under the following recommendations:</p> <ul style="list-style-type: none"> <li>a. To have no contact with the victim;</li> <li>b. Not to harass, assault or threaten the victim and any/all household members;</li> <li>c. Assessment at client Services and Family Counseling, and comply with any treatment recommendations;</li> <li>d. No alcohol, illegal controlled substances, firearms and dangerous weapons – applicable search allowed;</li> <li>e. Pay court costs;</li> <li>f. Obey all laws and not to leave Guam without the court's permission.</li> </ul> <p><b><u>For CM536-09:</u></b></p> <p>Placed on supervised probation for a period of two (2) years under the following terms and conditions:</p> <ul style="list-style-type: none"> <li>i. Perform fifty (50) hours of community service under the direction of alternative sentencing.</li> <li>ii. Stay away, directly and indirectly, from victim, <b>[victim's name omitted]</b>. No contact by phone, in writing, and/or through third party, including family member or friend.</li> <li>iii. Defendant shall not threaten, physically strike, or injure the victim, <b>[victim's name omitted]</b>.</li> <li>iv. Report to Client Services and Family Counseling for intake and assessment, and shall follow all treatment recommendations including psychological evaluation, psychiatric evaluation, drug and alcohol evaluation, individual counseling, group counseling and/or family counseling.</li> <li>v. Defendant shall report to DMHSA for an intake and drug and alcohol assessment and shall follow all treatment plans;</li> <li>vi. Defendant shall report to Adult Probation Office once a month in person or as ordered by the Adult Probation Office.</li> </ul>

	<ul style="list-style-type: none"> <li>vii. Defendant shall not possess or consume any alcoholic beverage or illegal drugs, and shall not enter any establishment whose primary business is the sale of alcoholic beverages.</li> <li>viii. Defendant shall submit to alcohol and drug testing.</li> <li>ix. Defendant shall permit probation officer to search his person, residence and vehicles for alcohol and illegal drugs at any time such a search is requested. Failure to allow such a search will be considered as a violation of probation.</li> <li>x. Defendant shall not leave Guam without the approval of the court or Adult Probation Office, with prior notice being given to the Office of the Attorney General.</li> <li>xi. Defendant shall comply with any court orders entered against the defendant including orders of the Family Court or any other local or federal court of competent jurisdiction.</li> <li>xii. Defendant shall abide by any other reasonable conditions imposed by the Court or adult Probation Office.</li> </ul>
