

Pay tuition fee; - Anger Management class. Pay tuition fee; - Report to Probation once a month; - No alcohol or illegal drugs. Not to enter establishment selling alcoholic beverages; - No firearms or FAID. Surrender firearm and FAID; - Alcohol and drug testing; - Permit Probation to search his person, vehicle or residence for alcohol, illegal drugs or firearms; - Surrender passport; - Not to leave Guam with notice and approval from probation and OAG; - Obey all laws. <p>For CF0709-15: Sentenced to one (1) year imprisonment, all suspended, with credit for time served; two (2) years probation under the following terms and conditions:</p> <ul style="list-style-type: none"> - Not to harass, threaten, assault victim and any/all family or household members; - Assessment at CSFC, and shall comply with any/all treatment recommendations; - Complete Anger Management program; - Pay \$100 fine, convertible, plus court costs; - No alcohol, illegal drugs and firearms. Allow searches to vehicle, person and residence; - Submit to alcohol and drug testing; - Not to leave Guam with court's permission; - Obey all laws.
