



PETITION TO REMOVE NAME FROM THE GUAM FAMILY VIOLENCE REGISTRY

To the Office of the Attorney General of Guam:

1. I, _____, (D.O.B. 00/00/00), am a resident of _____, with a physical address of _____. I have resided at this location for the past _____ months/years.

(If Petitioner did not reside at that residence for the past 10 years, Petitioner must provide with this petition all residences wherein the Petitioner has resided in the past 10 years.)

2. I submit this Petition to have my name removed from the Guam Family Violence Registry for the following reasons:

- a. A court order of expungement has been issued with respect to one (1) of two (2) of my family, domestic or dating violence, and/or stalking convictions, **which I have attached a copy of the expungement order to this Petition for consideration.**

(NOTE** Person requesting removal under this section cannot have two (2) or more additional convictions, or a conviction wherein the family, domestic or dating violence, and/or stalking offense has a special allegation of the use of a deadly weapon.)**

- b. During the ten (10) year period preceding the date of this Petition, I have not been convicted for any offense described in §30.10, Chapter 30, Title 9, Guam Code Annotated.

(NOTE** Any new conviction for domestic, family, or dating violence, stalking, criminal sexual conduct, aggravated assault, and/or homicide convictions, either on Guam or in any other jurisdiction of the United States, that occurred during the prior ten (10) year period SHALL be cause to deny this petition and to NOT remove the person from the Family Violence Registry.)**

3. I certify that I have not been arrested, charged or convicted with any new offenses of domestic, family, or dating violence, stalking, criminal sexual conduct, aggravated assault, and/or homicide since the date of my last conviction, either in Guam or in any other jurisdiction of the United States. I have attached the necessary police and court clearances to this Petition.
4. Based on the above noted reason, I am requesting that the Office of the Attorney General remove my name from the Family Violence Registry as I have met one of the above requirements under the law that permit that my name be removed.
5. I declare under penalty of perjury that the foregoing Petition and the contents thereof, and that the matters stated therein are true of my own knowledge.
